## Off The Record

### A Companion Volume to PM Cameron's 'For The Record'

One April day, in 2010, through the letter box of my 'finisher-home', came an election flyer. In big, boxy, red letters it was headed: '**A HUNG PARLIAMENT WOULD MEAN 5 MORE YEARS OF GORDON BROWN**'. This was immediately apparent as a lie, such that the name: '*Liar Flyer*' came readily to mind. Great Britain has more laws than you can shake a truncheon at, *yet*, this blatant lie was deemed in-order by a major political party (The Tories) and nodded-through by the various 'opposition' parties. The Liar Flyer comprised an eye-watering falsehood, repeated over and over, in a variety of ways, and finally approved in a summary by David Cameron, who signed-off the entire dog's breakfast. What was going on?

I investigated election law. 'The Representation of The People Act 1983' was precise: To pressurise a voter, in any way, ranging from the use of physical violence, down to presenting that voter with a '*fraudulent device or contrivance*', amounted to 'corrupt practice'. In legal-speak it was: 'Undue Influence'. The Act clearly ruled Cameron's Liar Flyer illegal. An open and shut case - I thought.

I approached the local Acting Returning Officer (one David Holling) who said the Liar Flyer was not in his remit. One wonders what was! Richard Benyon MP (Newbury) was adamant that there were no lies, in the personalised version of the Cameron Liar Flyer which he distributed. On further enquiry, I discovered not one Westminster office could, or would, address my concern, whilst two of the bodies I contacted, advised me to go to the police. The local police force was Thames Valley.

I made proper representations to Chief Constable Sara Thornton and received an agreeable ‘reply’ - from Assistant Chief Constable Ball. (At this time I had no inkling of the bottomless pit of corruption present in Britain; my ‘learning curve’ was to be steep.) I did, however know by now that the State had little concern for ‘democracy and rule of law’. When I wrote, again, to the police expecting support. I was met with a salvo from ACC Ball’s shiniest guns. The police *would do nothing*, she informed me. I withdrew in puzzlement.

I tried to find an authority on the English Language who would confirm the lies (later acknowledged by three legal gentlemen) but only succeeded in discovering what an ignorant nation we are. I also realised our language tends to be in the guardianship of ‘natural Conservatives’ - a class of people who do not confirm the lies of ‘their own’ - especially to the lowborn likes of me. (Loyalty trumps honour among ‘quality folk’.) I now knew I had opened a can of worms, but the extent to which those worms could wriggle was yet to unwind. Some of the worms would prove to be snakes; snakes that, repeatedly, dumped me back at a ladder-bottom.

Time passed. Chief Constable Habgood replaced CC Thornton whose departure made waves . . . I decided to gamble on the new Chief Constable actually being a ‘good cop’. I was disappointed. Perhaps there are none?

I wrote to CC Habgood, appealing to him both personally, and in his official capacity, for honourable and democratic support. I had been lied to by the Cameron/Benyon Liar Flyer collusion; lied to in an attempt to gain my vote! This broke election law (see above).

My reply came from DI Tyrrell (it seems Chief Constables, typically, find replying to bog standard citizens, in person, a



chore). Tyrrell wrote: “I cannot see any evidence”. DI Tyrrell clearly had, either a poor command of English, or he obeyed, to the letter, direction from CC Habgood, even to the point of stooping to wilful blindness. I was, from then on, in no doubt that corruption reigns in the higher ranks of Thames Valley Police. Where now? Where indeed!

At this crucial point, the elected office of ‘Police and Crime Commissioner’ was conjured up in Westminster. The very day that Thames Valley acquired one Anthony Stansfeld as its PCC, I sent him a documented complaint regarding the corruption amongst the top cops of Thames Valley Police. Despite his fulsome, *sworn* oath - to serve The People with more glitter than the Archangel Gabriel - Stansfeld stayed silent. His silence grew to mockery, and on - to insolence. In desperation, I took to my keyboard: “You might, at least, acknowledge my email” I chided. Stansfeld replied: “I acknowledge your email” - adding contempt and arrogance to his disgraceful tally. But, more helpfully, demonstrating that he, too, was corrupt.

I did not bother to complain to *his* superiors. . .

I conclude that Richard Benyon (and his kind) may lie for votes with impunity, even though the law states, quite clearly, that they may not. Richard Benyon may impose ‘undue influence’ on any number of Thames Valley voters, but not one of the voters targeted is granted a scrap of their own influence, to be applied in calling out the crime. This is Thames Valley ‘democracy under rule of law’. This is the tyranny of: **Undue Lack of Influence!**

As you might expect, I investigated the possibility of a Parliamentary Ombudsman, to whom I could complain about Benyon's fraud. I discovered that the office of Ombudsman covers both parliament *and* the NHS. The term: 'poor relation' loomed. Severely disheartened, I decided, even so, to continue seeking justice. It was then I encountered the very British procedure to be followed: fill in the correct complaint form and pass it to none other than Richard Benyon MP, who will forward it, if it's approved - *by him!* I enquired no further . . .

2015 was a good year for political opportunity. Dr. David Whyte of Liverpool University published 'How Corrupt is Britain?' (answer: '*utterly corrupt*') and I stood, again, for Parliament. By this time I had realised there is no democratic punishment for elite crimes, so I resolved to 'get them out of their prams'. I spent many hours in Newbury sunshine presenting to an almost wholly disinterested shambles of shoppers, the following sad truth: By using Cameron's flyer, Richard Benyon MP lied for votes while Thames Valley police corruptly looked away. All elite prams remained occupied.

Few of Newbury's shoppers had time nor inclination to be informed of their duped status. A very few starry-eyed Benyon-worshippers found a moment to glare. With ‘Brexit’ in full swing the two main performers on the Westminster stage have been Prime Minister Theresa May (contralto) and Attorney General Geoffrey Cox (‘base’) both notable for having acted appallingly with respect to Cameron’s Liar Flyer. Here is the detail:

Soon after the 2010 general election, I informed Home Secretary May (Special Delivery) that her boss, Cameron, had broken election law. She didn’t even reply! Can you believe that? Further, one of the notable users of the Liar Flyer was none other than Geoffrey Cox QC MP (his constituency being one of 18 to distribute the Liar Flyer). ## REPRESENTATION OF THE PEOPLE ACT 1983

### 115 Undue influence.

(1) A person shall be guilty of a corrupt practice if he is guilty of undue influence.

### (2) A person shall be guilty of undue influence—

(a) if he, directly or indirectly, by himself or by any other person on his behalf, makes use of or threatens to make use of any force, violence or restraint, or inflicts or threatens to inflict, by himself or by any other person, any temporal or spiritual injury, damage, harm or loss upon or against any person in order to induce or compel that person to vote or refrain from voting, or on account of that person having voted or refrained from voting; or

(b) if, by abduction, duress or any fraudulent device or contrivance, he impedes or prevents [F1, or intends to impede or prevent,] the free exercise of the franchise of an elector or proxy for an elector, or so compels, induces or prevails upon [F2, or intends so to compel, induce or prevail upon,] an

elector or proxy for an elector either to vote or to refrain from voting.
